**Explanation of Responses:**

1. This Form 4 reports an acquisition on December 20, 2017, by the following entities: (a) Stilwell Activist Fund, L.P. (SAF) of 825 shares of KFS common stock at \$5.2333 USD per share, and (b) Stilwell Activist Investments, L.P. (SAI) of 6,675 shares of KFS common stock at \$5.2333 USD per share.

2. After giving effect to the transactions reported herein, the shares of KFS common stock reported under Column 5 of Table I above are held directly by the following persons or entities: Joseph Stilwell (162,500 shares); Stilwell Associates, L.P. (Associates) (903,066 shares); SAI (2,541,025 shares); and SAF (314,232 shares). Of the total shares of KFS common stock reported under Column 5 of Table I above, 3,758,323 shares are beneficially owned indirectly by Joseph Stilwell in his capacity as the managing member and owner of Stilwell Value LLC, which is the general partner of SAI, Associates and SAF. Joseph Stilwell disclaims beneficial ownership of all shares reported as owned indirectly except to the extent of his pecuniary interest therein. The address of SAI, Associates and SAF is the same as the address reported in Item 1 of this Form 4.
