

KINGSWAY ENTERS AGREEMENT WITH SYNDICATE OF UNDERWRITERS

TORONTO, ONTARIO (December 12, 2001) - Kingsway Financial Services Inc. (TSE,NYSE:KFS) has entered into an agreement with a syndicate of underwriters comprising HSBC Securities (Canada) Inc., CIBC World Markets Inc., Fox-Pitt, Kelton, Inc., RBC Dominion Securities Inc., Scotia Capital Inc., Advest, Inc., Cochran, Caronia Securities LLC, National Bank Financial Inc. and Raymond James & Associates, Inc. to offer 7,500,000 common shares at Cdn\$16.50 per share in Canada and US\$10.49 per share in the United States, for gross proceeds of approximately Cdn\$123,750,000. Closing of this transaction is expected to occur on or about December 19, 2001.

Kingsway has also granted the underwriters an option to buy up to an additional 1,125,000 shares at the offering price until January 10, 2002.

The net proceeds from this offering will be used to augment the capital of the Company's subsidiaries and for general corporate purposes.

The Company currently operates through nine wholly-owned subsidiaries in Canada and the U.S. Canadian subsidiaries include Kingsway General Insurance Company, York Fire & Casualty Insurance Company and Jevco Insurance Company. U.S. subsidiaries include Universal Casualty Company, American Service Insurance Company, Southern United Fire Insurance Company, Lincoln General Insurance Company, U.S. Security Insurance Company and Avalon Risk Management, Inc. The Company also operates reinsurance subsidiaries in Barbados and Bermuda. Kingsway Financial, Kingsway General, York Fire, Jevco and Kingsway Reinsurance (Bermuda) are all rated "A" Excellent by A.M. Best. The Company's senior debt is rated 'BBB' (investment grade) by Standard and Poor's. The common shares of Kingsway Financial Services Inc. are listed on the Toronto Stock Exchange and the New York Stock Exchange, under the trading symbol "KFS".
